***In the event that any beneficiary of a specific gift does not survive me then such gift shall become part of the residue of my estate.***

***My Personal Representatives shall hold what is left of my estate on trust to sell or retain it and:***

- A. Pay my debts and my funeral expenses.
- B. After meeting these expenses pay the residue of my estate to my spouse, William David Smith. In the event my spouse, William David Smith, does not survive me, then I leave the remainder of my estate to each of my surviving children in equal shares.

A. Pay my debts and my funeral expenses.

B. After meeting these expenses pay the residue of my estate to my spouse, Jessica June Smith.
